Study programme for which it is organized: the Serbian language and literature, the Italian language and literature, the Russian and Serbian language and literature.

Connection to other subjects: No.

The subject's objectives: The subject creates a detail insight into the theory of novel. By providing insight into theoretical framework of most important scholars of the genre, different methodologies, literary and style analysis and interpretation of selected works, the subject will enable students to acquire chronological overview of most important periods and important works within literary and historical development of the genre. The subject covers and analyzes some of most important novels of the world and Serbian literature in order for the students to be well introduced to history and poetics of the genre, as well as to literary and theoretical aspects of the study of the genre.

Objectives: The students will acquire knowledge in the area of poetic interpretation and practical interpretation of literary works belonging to Romanesque genre. The students will acquire theoretical knowledge, knowledge in the area of history of novel; they will read and interpret works of some of most important novelists of the Serbian and world literature. Theoretical framework consists of basic concepts, definitions, classifications and systematization of the works belonging to Romanesque genre.

Methods of teaching and acquiring lessons: Lectures, required reading, seminar paper, discussion.

Content of the subject: Theoretical aspects in the work of Lukach, Bakhtin, Kundera, Forster, Meletinsky and other authors who dealt with the concept of this genre – from priest lea to Umberto Eco. The aim of the conent is to acquire theoretical knowledge and abilities to apply contemporary interpretations and terminology regarding the novel, which particularly refers to originality, dialogues, chronotype, poliphony, intertextuality, fiction, metafiction and carnivalization. The historical overview of the Romanesque genre will begin with acnient Greek, Roman, Byzantine and Medieval chivarlic novel. Then, the students will interpret Apuleius's Golden Donkey, Petronius's Satyricon, Rabelais's and Cervantes's, and novels of 18 century in terms of metafiction, Prevost's Manon Lescaut, Defoe's Moll Flanders, Diderot's Jacques the Fatalist, Voltaire's Candide etc. until great novels of 19 and 20 century, where the focus will be on different topics that are important or the study of theoretical aspects of novels.
